This SUPPLEMENTAL DEED executed at Chennai this the 9th day of June 2017

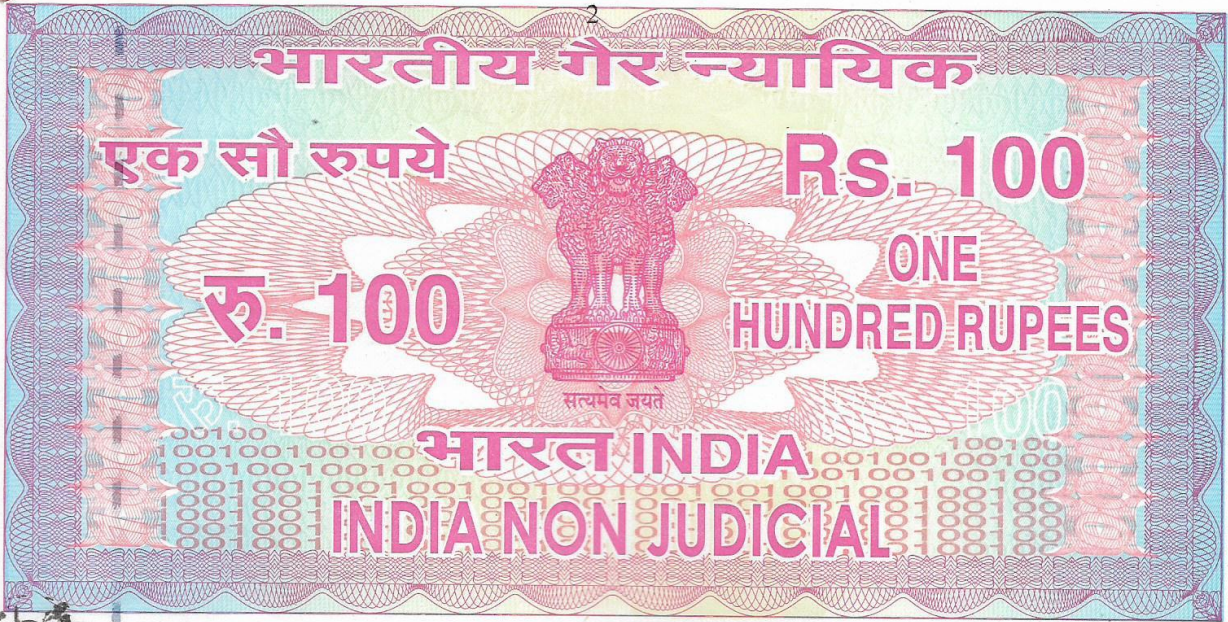

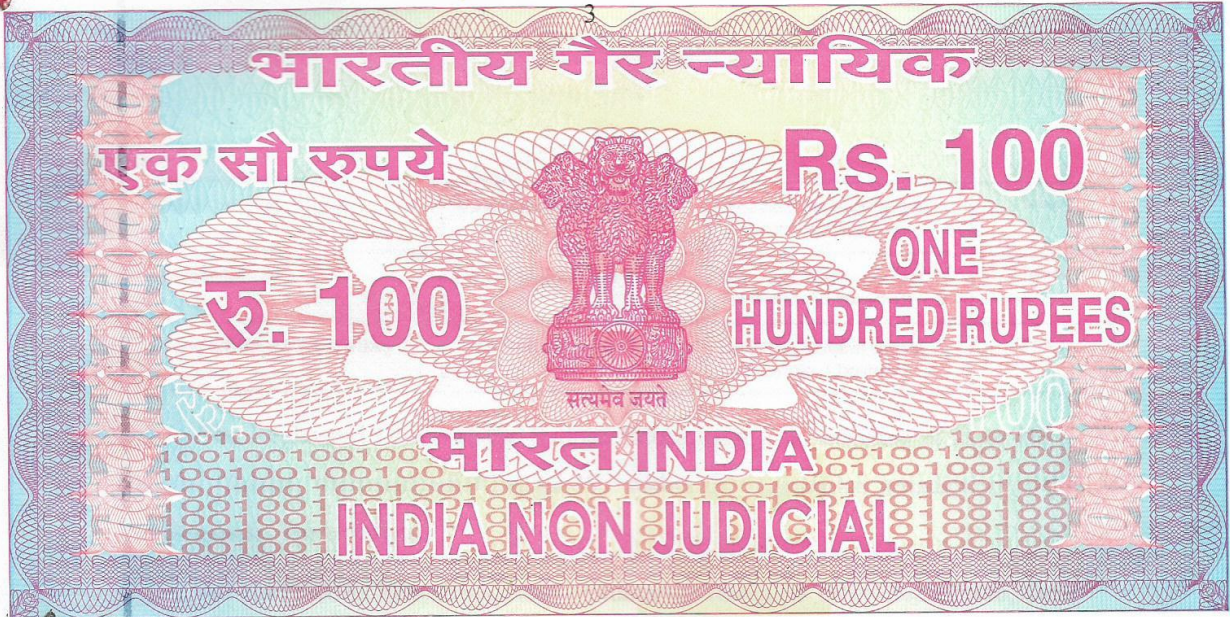
NOW THIS DEED WITNESSETH AS FOLLOWS

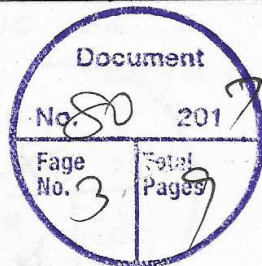

6. With the appointment of aforesaid new trustee, the Principal Trust Deed dated 15.09.1993 shall remain in full force and effect, which shall be part and parcel of this Supplemental Deed.


The Corpus Fund of the Trust is only Rs.1001/- and there is no movable or immovable property involved in this Deed.
